2.8 To establish, maintain, run, develop, extend, grant donation for and to aid and assist in the establishment, maintenance, running, development, improvement and extension of Hospitals, Clinics, X-ray plants, Dispensaries, Maternity Homes, Old Age Homes, Recreation centre and all similar institutions as will afford treatment to alleviate human suffering and for the benefit of the poor.

6.4 The first Trustee named above and the other Trustees who may be inducted hereinafter into the trust shall hold such or nomination as the case may be but shall be eligible for reappointment or renomination.

6.5 Whenever a vacancy of Office of the Trustee(s) arises by death, resignation, expiration of a period of the office or otherwise, the Chairman shall have the power to fill up such vacancy or vacancies with the approval of the Board of Trustees.

6.6 Any Trustee can voluntarily demit the office of the Trusteeship by conveying the same in writing to the Chairman/Secretary and such communication shall be placed before the Board of Trustee for its consideration and acceptance.

6.7 Any Trustee other than the Founder Trustee, whose work and activities will not be found satisfactory, can be removed from the Trusteeship. Such removal must have the approval of the minimum 60 percent of the total members of the Trust Board.

6.8 Any Trustee including the Founder Trustee convicted of any crime shall immediately be removed from the Board of Trustees.

13.1 The Secretary and Chairman may appoint experts and advisors and secure their service and advice to further the object of the Trust and incur necessary expenditure thereof.

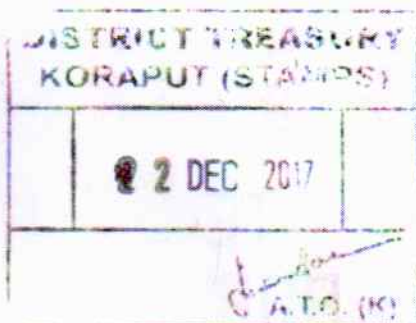

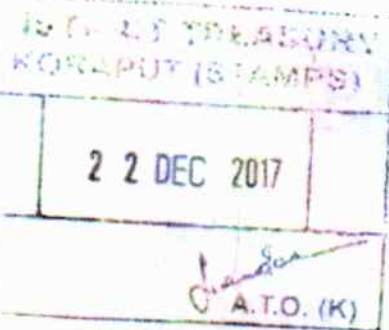
